### Awareness Program on "ANTI-RAGGING MEASURES AND DISCIPLINARY ACTIONS ON INDULGE RAGGING PERSON"

Dr. K.N. Rajanikanth, an eminent personality started the awareness session by defining ragging as stated by the Honourable Supreme Court of India and Raghavan Committee and then proceeded to discuss a few cases of ragging in India that resulted in death and severe damage to the mental state of victim and victim's family. He also stated that the highest numbers of ragging cases were reported in 2019 as per UGC. He also discussed about various form of ragging to make sure that the students are able to understand which activities are stated as ragging in UGC rules and regulation. He discussed about the various punishments given in the case of ragging.

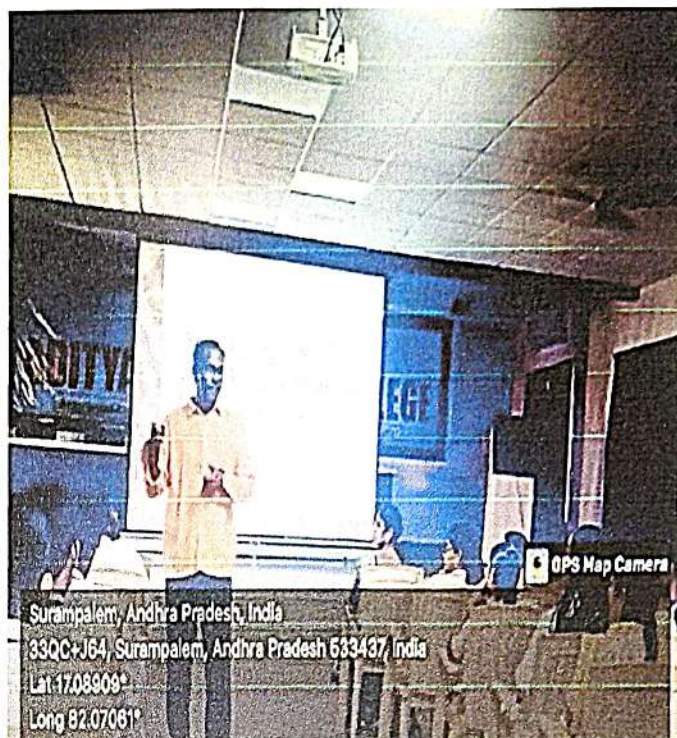
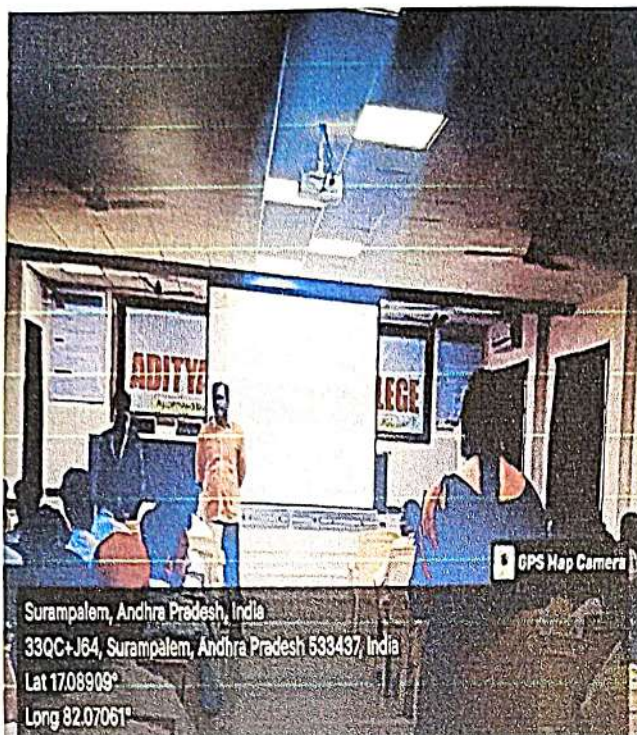
Dr. K.N. Rajanikanth, in his address to the students passionately emphasized the significance of Anti-Ragging Measures and Disciplinary Actions on Indulge Ragging Person. He spoke about the origin and menace of Ragging in India and the different spheres to it. He also explained the legal consequences of involvement in such activities. He also reiterated that anyone who is actively or passively, or is a part of a conspiracy to promote ragging, is liable to be punished. Moreover, he also briefed the students about the anti-ragging regulations, their legal and health consequences if failed to adhere to them.

Dr. K.N. Rajanikanth highlighted the Honourable Supreme Court's Guidelines to be followed by universities, colleges and other educational institutes to curb ragging. He also discussed the Raghavan Committee Report on Anti-Ragging and UGC guidelines of 2009. He educated the students on the procedures for registering complains and how to participate in making ragging free campus. He responded to queries from students with respect to anti-ragging and the talk concluded with a call to 'Say no to Ragging'. Finally vote of thanks was given by Dr. P. Bhaskar Rao, member of Anti-Ragging Committee and concluded the session.
