It is unanimously resolved approving the guidelines for Anti-Ragging.






16. These teachers will also enquire the welfare of students themselves. They shall submit weekly reports to the Convener Anti-Ragging Committee regarding interaction with students.
17. As far as possible, fresher's should be segregated from seniors in hostels in separate floors earmarked for them.
18. No senior students will be allowed in the floor/room/varanda/dining room of hostel earmarked for fresh students.
19. Security guard will remain on duty in floor of fresher's and will not allow any senior student to enter that floor.
20. Fresher's will be advised not to enter any other floor/room in the hostel.
21. Relevant abstract from the prospectus regarding discipline and proper conduct shall be displayed.
22. One security man shall always be available at the main entrance of Boys hostel and second security man will be at floor of fresher's.
23. A Proper record of students coming late night (after 10:00PM) will be maintained by Hostel wardens.
24. Action to be taken in case a ragging incident is reported.
 - i. Convener of Anti-Ragging Committee to be informed within 15 minutes, either directly by the individual or through any faculty member.
 - ii. Victim to be interviewed by the Convener, Anti-Ragging Committee within 2 hours.
 - iii. Accused to be interviewed by the committee within 4 hours.
 - iv. Final outcome to be decided within 6 hours.
 - v. Meeting of victim & accused to be arranged within 12 hours.
 - vi. In case the victim is not satisfied, parents of victim as well as accused to be called within 24 hours & details given to the parents.
