- 1. In case of any reported incident/complaint, an emergency meeting will be held by the convener at any time.
- 2. Complaint against ragging if any, shall be submitted to the Convener Anti Ragging Committee, the principal.
- 3. Duty roster for duties in hostels will be published by the Convener of the Committee.
- 4. Duty roster will not be changed without the consent of the Convener of the Anti Ragging Committee.
- 5. A written report will be submitted by the Individuals on-duty to the convener of Anti Ragging Committee if any incident happened.
- 6. All the students have to carry ID card while in the campus, failing which they may be penalized.
- 7. Different Library timings are scheduled for the fresher's.
- 8. Hostel timings including meals timings shall be notified by the respective hostel warden in the hostel notice board.
- 9. All fresher's will dine in the separate dining hall during the specified hours. Warden should be present during that period.
- 10. Awareness will be created for in the fresher's on 1st day during formal address by the Principal.
- 11. Regular scrutiny will be carried out to detect unreported ragging.
- 12. Action will be taken against students who indulge in ragging to the satisfaction of the victim or their parents.
- 13. Hostel Warden will examine the contents of Anti Ragging complaints/suggestion box kept in hostel daily at 09.00AM and report to the Convener if any complaint of ragging is found.
