2.5 EVALUATION PROCESS AND REFORMS:

2.5.1 MECHANISM OF INTERNAL ASSESSMENT IS TRANSPARENT AND ROBUST IN TERMS OF FREQUENCY AND MODE:

RESPONSE:

- Evaluation process in Aditya college of Pharmacy is transparent, adaptable and robust.
- Aditya college of Pharmacy is affiliated with Jawaharlal Nehru Technological University, Kakinada, Andhra Pradesh adheres to the academic calendar year examination for the academic year 2023-24 and evaluation procedures established by the university has followed for all programs.
- The program's academic calendar is published by PCI on its website, http://www.pci.nic.in. In Every new academic year, the institute holds an orientation programme for newly admitted students and their parents during which the Principal and College Examination In-charge, explained in brief to the students the specifications of the examination pattern, the making of the OMR sheets, the evaluation system and the passing standards.
- Every academic year, the academic calendar is published by JNTUK which is uploaded to the university website. JNTUK provides the start date of the academic year, mid examination schedule and the semester end dates for the B.PHARMACY,M.PHARMACY AND PHARM.D students. Academic calendar is visible on notice boards and in the classrooms.
- This year, as the institute operates autonomously, first-year students in B.Pharmacy, Pharm.D, and M.Pharmacy programs adhere to the evaluation process by utilizing BET-PRO.
- The autonomous papers of internal examinations are evaluated using BET-Pro. This method ensures a consistent and high-standard evaluation process for all students.
- An examination committee has been formed to plan, monitor, and organize examination duties. One Person by University directives from the institute has been appointed as an Examination in-charge. He conveys all the information about the internal and external exam date, Timetables and other exam-related issues. Three mid-examinations are conducted for Pharm.D students spanning throughout the year and the two Mid mid-examinations are conducted for B.Pharmacy and M. Pharmacy as per norms in each semester.
- The test component of the question paper must only be prepared by the faculty for the midterms before the allotted time given by the exam cell.
- The Exams were conducted reliably with proper seating arrangement and an invigilator was assigned for every 24 students.
- Students are made aware of the guidelines before the start of the exam.





- An internal Squad Committee has also been assigned to some of the designated faculty members to oversee the conduct of mid-term examinations and to prevent examination malpractice.
- The institute adheres to JNTUK regulations, for the internal evaluation of theory and practical subjects.
- The Evaluation of Lab exams for B. PHARM, M. PHARM and PHARM.D is based on ongoing internal assessment, which takes into consideration assessing their daily performance, keeping track of observations, and submitting records every week
- By using an online portal of JNTUK the marks scored by the students in the examination have been uploaded by the Exam cell.
- For future reference and validation, the written responses are saved and documented.
