Sir/Madam


With reference to the Subject cited above, I am directed to inform that subject cited issue was considered by 93rd Central Council in its meeting held in July, 2013 which noted that there is a demand from the Pharm D students for payment of stipend during internship on the lines of MBBS students.

Hence in view of above, it was decided that either -

- a) the institution shall collect only 50% of the fee from the student in the VIth year during internship period.
OR
b) pay stipend @ Rs.5,000/- per month during the VIth year (Internship period).
