

## Annual Report 2023-24

Aditya college of pharmacy has commenced working from the academic year 2006. The first batch of students has passed out in the year 2010. The intake of B. Pharm program is increased from 60 to 100 with PCI approval in 2011. In 2012, college affiliation was changed to JNTU Kakinada. The college was given permission to conduct Pharm. D program with PCI approval in the year 2014. College name has been changed from Sri sai Aditya Institute of sciences and technology to Aditya college of pharmacy in 2016 and the college secured PIO status to admit foreign students. ACOP is approved by UGC under sec 2f, PCI, AICTE, APSCHE, AISHE, recognized by government of Andhra pradesh and it is formerly affiliated to JNTUK. ACOP became an autonomous organization this year. ACOP certified with ISO and participating in NIRF since academic year 2016. ACOP also achieved education excellence award. ACOP provides good infrastructure for holistic development of students and faculty members. The college has started the post graduate courses like Pharmaceutical technology and Pharmacology (M. Pharm) from 2010. The college has started the Pharm. D Course from the year 2014.

The students of B.Pharm, M.Pharm and Pharm.D in ACOP are made to undertake projects/internship/field works. Total 135 students undergone project this year. Out of that 92 are B.Pharmacy, 9 M.Pharmacy and 34 pharm.D students.

The College has acquired sophisticated equipment such as FTIR, ROTARY EVAPORATOR, DEEP FREEZER, AUTOMATED HAEMATOLOGY ANALYSER and installed in various laboratories. Realizing the importance of web based learning the management has provided a high speed internet

laboratory for the students and faculty. ACOP offers Add on courses for the Students which help the students to think out of the box. Total 7 courses were offered this year for students and 503 students were enrolled in it in this academic year. Total number of students admitted in the college for this year is141.B.Pharmacy-106,Pharm.D-26,I M.Pharm-9.Total number of students for 23-24 is 592.Number of faculty 41.Mentor mentee ratio is 1:14.

Average percentage of full time teachers against sanctioned post is 100%. The college has 8 qualified Ph.D holders. ACOP also carries extension activities for sensitizing students to social issues. Total NSS activities carried out this year is 29. ACOP gained Certificate of appreciation for Anti Tobacco Campaign at Gorinta and certificate of appreciation for free medical camp at PULIMERU. Students of Aditya college of pharmacy distributed free medicines in the village.

During current AY, a sum of rs 94,500/- was disbursed to faculty and students as incentives for publication, books/chapters, patents and innovative projects. Total publications in this AY are 55.

There is huge collection of books and journals which are subscribed regularly. The institution has subscription for e-resources. This year DELNET and KNIMBUS e-resources were renewed. The annual expenditure for the purchase of books is 2,08,120 /- and journals is 16,138 /- Total 8 journals were newly subscribed this year.

Total number of students benefited with scholarships this year is 283.

The students are given coaching in the III and IV year for the GPAT examination. Total 155 students were given coaching for competitive exams this year. Two students qualified in NIPER and 21 students in PGE CET.

Total 22 webinars, 4 FDP were conducted in this AY. Two day national conference PHIDAGE 2024 was conducted on pharmaceutical industry in the digital age: Emerging trends and opportunities. Recognised research guides for this academic year is 2. Final year B.Pharm students

were taken for industrial visit to Seldom pvt Ltd, Yanam, AMTZ VSP. The institution made MOU with Indian Biomedical Skill Council this year.

The institution has a transparent mechanism for timely redressal of student grievances including sexual harassment and anti ragging committee. No grievances for students and faculty were observed in this academic year. No cases were received under RTI act. NO cases were received by ICC and NO malpractice cases found. Total committees were present in the institution were 25.

Students of B.Pharm and M.Pharm from ACOP are placed in MEDTECH-21,HETERO-6, LAURUS-8, EPISOURCE-15, MSN-7, IDS-2,24/7 AI-4. Total 49 students of B.Pharmacy,10 students of Pharm.D,4students of M.Pharmacy were placed with highest package 5 LPA.. All students are placed with good package. Total number of students selected for placements in this academic year is 63. Total certificates received by the students of ACOP in university/state level sports competetions are 6.out of them 4 certificates won in Athletics,1 in javelin throw and one participation certificate in foot ball. Total sport competitions and cultural programs were conducted by the institution this year are 7 and 13 respectively.

Alumni contribution received for this AY is 1,34,676 /- Out of this, 33,866 /- amount was spent to purchase balances in laboratories.

Aditya college of pharmacy established the IQAC officially on 4<sup>th</sup> July,2018.Right from the inception, IQAC has been an integral part in developing a system for conscious, consistent and catalytic improvement in the overall performance of the college. It is committed towards quality enhancement in the institution. This year 2 meetings were conducted by IQAC. The institution participated in NIRF. IQAC initiated to conduct webinars from different departments. 4 Faculty development programs were conducted in online mode. Total 5 professional training programs were conducted on purchased equipment for both teaching and laboratory personnel.one administrative training program was conducted for non teaching staff on financial management. Electoral literacy committee was formed to create awareness regarding importance of elections, voting and voting procedure in rural villages. Student Satisfaction Survey was conducted and key areas were identified by IQAC to strengthen quality in the

institution. An orientation program was conducted for first year students. Two day career guidance program was conducted on "Personality development and study skills" An awareness seminar on "overseas education and study in USA" for final year students. An interactive session for faculty with experts from various institutions. One day workshop on study techniques was conducted. Teaching fraternity and lab personnel were given training on purchased equipment. IQAC conducts Academic & administrative audits each year to map all department functionalities towards the vision and mission of the college. Library audit and project file audit were conducted.

The institution has conducted 3 programs under ethics committee. The institution has also conducted 3 gender sensitisation programs to promote gender equality. Two best practices are implemented this year.1.overcoming the myth surrounding prospects of pharm.D through experiential training and learning during clinical visits. 2. Employment of female faculty members-A step towards women empowerment.
