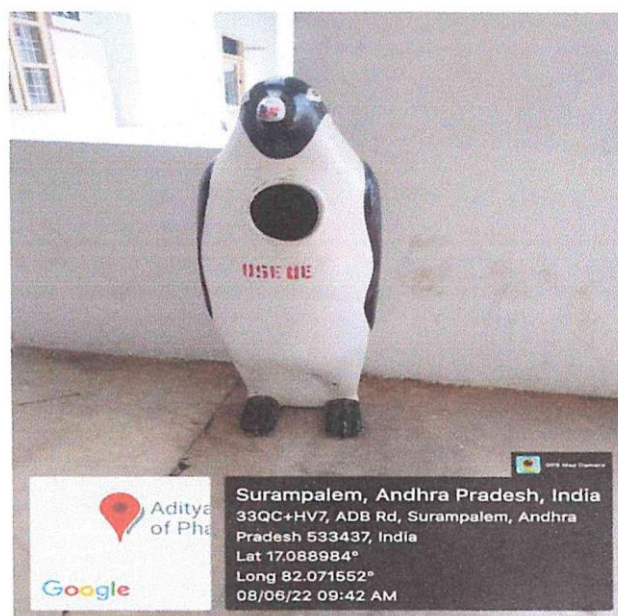

Policy Document on Restricted Entry of Automobiles:

20-06-2015

As per the Directive of Higher education and Environment Protection Act, 1986

The following rules must be properly followed in order to preserve the environment on campus:

- To keep campus emissions to a minimum
- Entry of any form of motor vehicle into the campus is absolutely forbidden.
- Only backup vehicles, such as an ambulance or fire truck, are allowed on campus during crises.
- With prior approval from the principal and higher authorities, people who are physically challenged are allowed to drive less polluting automobiles on campus.
- Nudging faculty and students to drive greener automobiles like bicycles
- If motor vehicles are utilized in campus, it will be subject to punishment.

Policy Document on Ban on Use of Plastic in the Campus:


20-04-2016

In accordance with the central government's notification on Plastic Waste (Management and Handling) Rules, 2011 under Environment Protection Act 1986, the following the order issued by Environment, Forest, Science and Technology department, Government of Andhra Pradesh.

The college created a plastics ban policy.

- Single use plastics are strictly prohibited in the campus
- It is forbidden to use carry bags made of biodegradable plastics for transporting, storing, or packing consumable food or any other materials within the campus.
- Products made of recyclable plastic should be disposed of in the bins provided.
- Running campaigns to raise awareness of the plastics ban.
- Promoting environmentally friendly products like paper bags, steel bottles, and glass bottles.
- Regular monitoring of the plastics ban.
