REPORT ON WORLD ENVIRONMENT DAY

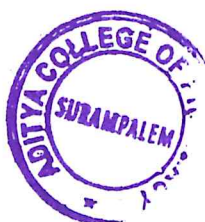

On the other hand they taught people about the significance of planting trees and how we could get recover the catastrophic effect on our nature.



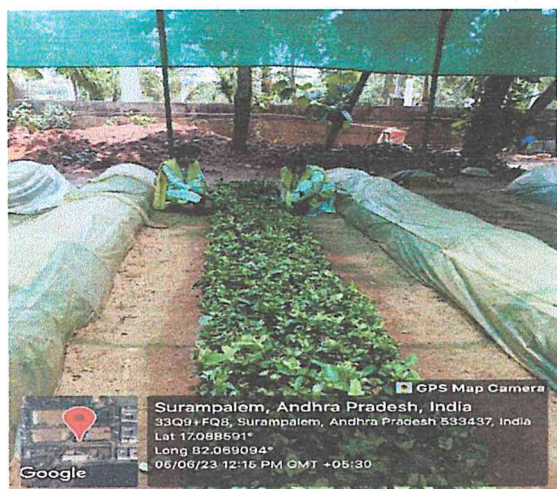


Fig: Students involved in cleaning and protecting the environment

- Phenols are strong disinfectants and toilets cleaned with phenols are more hygienic to use.



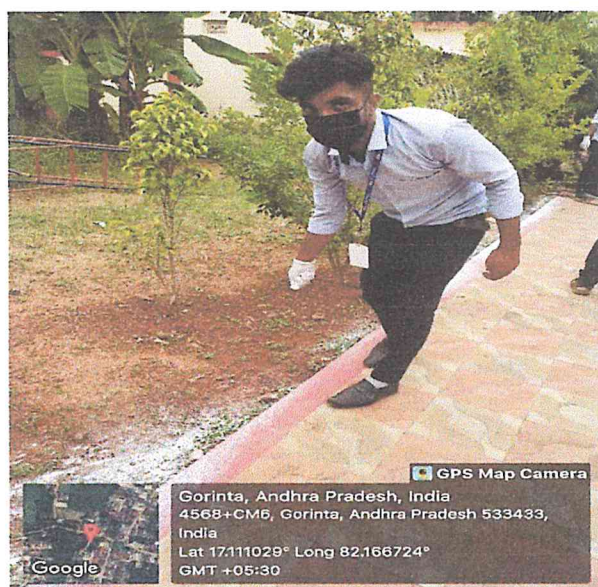


Fig: Students involved in the sanitation program by spraying the bleaching powder on the edges of road and in the primary school

- Reduces energy costs and making it economically sustainable.



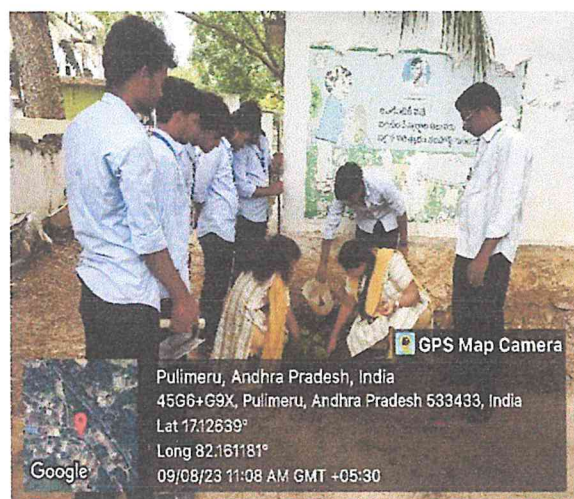


Fig: Students planting trees

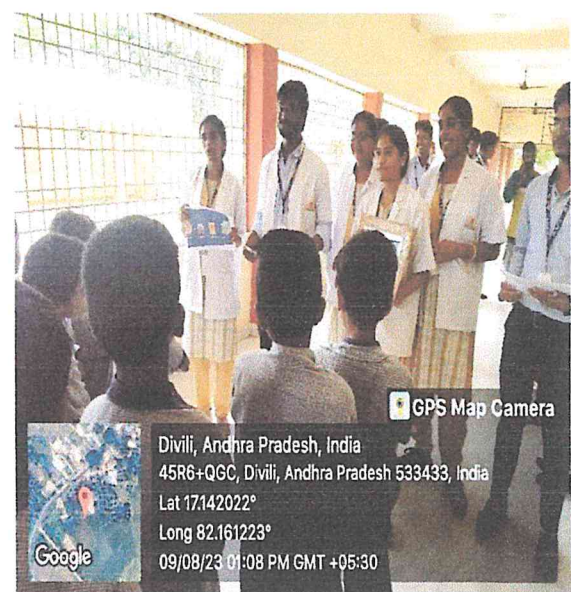


Fig: Explaining the RRR concept to students in a primary school
