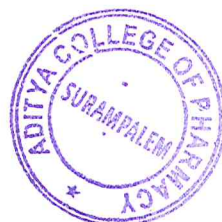


It is observed that there is an improvement in MoU and activities under the collaborations increased slightly in the last AY 2018-19 so this year also need improvement in MoU's.
