

Admission to the Master of Science in Mechanical Engineering

Dear prospective student,

I'm glad to inform you that your application to the two-year Master of Science (Laurea Magistrale) in **Mechanical Engineering** offered by the University of Cassino and Southern Lazio, Italy, has been positively evaluated. That is, you are eligible to be enrolled in **Fall 2019**.

The Master program is taught in English.

In order to complete the application procedure, we invite you to go through the following steps (according to the Italian law for non-European citizens living abroad).

You need to:

L Deliver personally your pre-application form + required documents to the competent diplomatic authority

The competent diplomatic authority is generally the Italian Embassy/Consulate closest to the place where the awarding institution is located. We suggest to go through this step at the soonest (even if deadline is on July 24).

To fill in the pre-application "A Form"

(you can download it from http://www.studiare-in-italia.it/studentistranieri/), please consider that:

- 1. the Academic Year you are applying for is: 2019/2020;
- 2. the official name of the University is: University of Cassino and Southern Lazio;
- 3. the programme is an ordinary 2nd cycle degree course named: Mechanical Engineering.

For the documents required by the Embassy, please check the Embassy website before applying. Do not forget to bring this *Eligibility for enrollment* letter (lettera di idoneità all'immatricolazione), duly signed by the University.

Given that the programme is taught in English, you **do not need** to provide any certificate as regards Italian language competences, neither to pass the Italian exam once in Italy. However, you need to provide a certificate proving your competence in English (unless your degree courses have been taught in English).

Start your Visa application procedure (see http://vistoperitalia.esteri.it/home/en)

Note that the University of Cassino and Southern Lazio does not require that you present the Declaration of Value or any statement of comparability when you apply for the visa. These documents might be submitted at the time of the enrollment, upon your arrival in Italy.

Once the Italian Embassy/Consulate notifies our University about your pre-enrollment application (this will happen at the end of July/ beginning of August), the University of Cassino and Southern Lazio will confirm to the Italian Embassy/Consulate you are eligible to enroll the programme.
